Welcome! You have the option of receiving 50% of the selling price in Store Credit or 35% by Check.

- Store Credit remains in your account until applied toward a purchase.
- Store Credit may be applied toward the purchase of any new or used item in Chloe's Closet.
- Store Credit may not be used to pay for sales tax or bag fees.
- Checks are mailed out approximately every 8-12 weeks to any accounts with at least a \$12 balance.
- Last check payout was done _____
- Check payouts include a \$2.00 processing fee.

- All consignment is subject to an item fee at the time of sale. The item fee is paid for by the buyer of the item and does not affect your consignment payout. This fee goes to help cover the costs involved in processing consignment.
\$1 - \$10 = \$1 Item Fee / \$10.01 - \$19.99 = \$2 Fee / \$20.00 - \$39.99 = \$5 Fee / \$40.00 & up = \$10.00 Fee
- The consignment period for clothing and toys is 4 weeks (28 days).
- Once items are left for consignment, they will not be returned to you. Please be ready and willing to part with them at the time of drop-off. At the end of the consignment period, any unsold items become the property of Chloe's Closet and will be given to needy families or donated to a local charity.
- Chloe's Closet reserves the right to price items left for consignment, based on what our shoppers are willing to pay. Even after items have been accepted for consignment, we reserve the right to further reject any items we feel our shoppers would be unlikely to purchase for any reason
- We pledge to do our best to safeguard your items, but we cannot be responsible for loss or damage due to fire, theft, vandalism or natural disaster.
- We are unable to follow up with each individual consignor, but you are welcome to contact us if you have any questions about your current balance or if you have any inquiries about an item that you have consigned with us.
